I. GENERAL PROVISIONS

INFONOTARY PLC (the PROVIDER) sets the prices and subscription fees for the use of its qualified trust services, as well as the prices of goods related to these services (such as smart cards, readers, tokens, etc.), and publishes them in the Tariff for the Provision of Qualified Trust Services (the TARIFF), which is publicly available at: http://www.infonotary.com.

The PROVIDER reserves the right to unilaterally amend the TARIFF at any time during the term of the contract. Any changes are approved by the Board of Directors of INFONOTARY PLC and published at http://www.infonotary.com. The PROVIDER shall notify the HOLDER/CLIENT either individually or by the act of publishing the changes. The changes become effective and binding on the HOLDER/CLIENT as of the day following the notification or publication.

Within 7 (seven) days from the date of the change, the HOLDER/CLIENT has the right to unilaterally terminate the Qualified Trust Services Agreement (the Agreement) by submitting a written notice to the PROVIDER. In this case, the Agreement is deemed terminated as of the date of the change, and any fees already paid under the Agreement for the use of services are non-refundable. In the absence of such notice, the HOLDER/CLIENT is deemed to have accepted the changes.

The changes apply prospectively and do not affect any one-time or subscription fees paid in advance prior to the effective date of the change.

I.1. Fees under the Qualified Trust Services Agreement / General Terms and Conditions for the Use of Qualified Trust Services via Mobile Application and Web Portal

All amounts due by the HOLDER/CLIENT for the services and goods requested and used under the Agreement / General Terms and Conditions are determined based on the current TARIFF.

Prepaid amounts or subscription fees are non-refundable to the HOLDER/CLIENT in cases where the respective services are not used during the paid period.

In the event of early termination of a qualified certificate issued and accepted by the HOLDER and/or of the Agreement for reasons beyond the PROVIDER's responsibility, the HOLDER/CLIENT is not entitled to a refund of the remaining amount for the unused portion of the terminated certificate, nor of the prepaid package/subscription for the unused period.

All amounts due under the Agreement shall be paid by the HOLDER/CLIENT through one of the following methods:

• By bank transfer to the PROVIDER's payment account, as specified in the invoice issued by the PROVIDER;



- Via the EasyPay or ePay.bg systems, using a payment code automatically generated for each transaction;
- By bank card through an online payment system, if this payment method is available for the respective service;
 - Through the PROVIDER's mobile application (in-app purchases);
 - By using other electronic payment methods made available by the PROVIDER.

The Qualified certificates for Cloud-based Qualified Electronic Signature (Cloud QES) are used for signing documents. The service is paid either through an annual subscription by the HOLDER, a prepaid package by the CLIENT, or by a third party. Payment for prepaid packages/subscriptions for the use of Cloud QES is made at the time of their request.

The service fees do not include any charges related to the execution of the payment transaction itself, which are owed by the HOLDER/CLIENT to the respective payment service providers.

A bank transfer is considered completed once confirmation is received that the PROVIDER's bank account has been credited with the full amount due.

I.2. Invoicing

The PROVIDER issues a tax invoice to the HOLDER/CLIENT for the provided services within five (5) days from the date of payment.

I.3. Certificate Return and Refund Policy

In the event of objections by the HOLDER/SEAL CREATOR regarding inaccuracies or omissions in the issued qualified certificate, submitted within three (3) days from its publication in the Certificate Register, the PROVIDER shall revoke the disputed certificate and either issue a new one free of charge or refund the amount paid for the disputed certificate.



II. PRICES FOR THE USE OF QUALIFIED TRUST SERVICES PROVIDED BY INFONOTARY

All prices in the TARIFF are presented in BGN and EUR for the purpose of dual display, in accordance with the Law on the Introduction of the Euro in the Republic of Bulgaria. The values in euro are calculated using the official fixed exchange rate of the Bulgarian lev to the euro:
